Virtual Workshop: Equal Opportunity and Prop. 16

The Asian Pacific State Employees Association (APSEA) and the Association of California State Employees with Disabilities (ACSED) are partnering to host a virtual workshop on Tuesday, October 13. The workshop will be from 5:30 p.m. to 7:00 p.m. and will be presented through Zoom.

We are excited to have civil rights attorney William Tamayo join us as the keynote speaker to discuss current trends in equal employment opportunity, including the latest data related to diversity in public sector employment.

Also to be discussed in the session is Proposition 16, a measure appearing on this November's ballot. Prop. 16 would reverse the 1996 ballot measure Prop. 209, which prohibits both discrimination and favorable treatment based on race or gender for state college admissions, civil service employment, and government contracting.

Presenting viewpoints in favor of Prop. 16 will be Sally Chen from Chinese for Affirmative Action.

Presenting viewpoints in opposition of Prop. 16 will be Joy Chen from Californians for Equal Rights.
